Terms and conditions of the Promotion **"Don't be a fool!!"**

MEDITERRANEAN CAM INTERNATIONAL HOMES S.L. (here after Mediterranean), with the head office in C/ Severo Ochoa 44, edificio 11 2ª planta sito en Elche and the registered address in Alicante, Avenida Oscar Esplá, 37, con Número de Identificación Fiscal B-62718549, document IV, with the aim of awarding clients for their loyalty, will hold a prize draw for a **3D television**.

Mediterranean, for this, numbers will be allocated to all of the clients that fulfil the conditions required to participate in this promotion.

Mediterranean, in the case that any questions arise from the application of these present terms and conditions, shall interpret and apply them in the spirit of the promotion, the objective of which is to reward its clients for their loyalty.

The participation in this promotion supposes the acceptance in their entirety of the terms and conditions of the same.

1. PARTICIPANTS

Elegible participants:

- Persons over the age of 18, persons in legal representation of a Company, Associations, Residential Communities, Cultural Societies, Foundations, Local Corporations, Autonomous Organisations and Religious Congregations.

Non eligible participants:

3. HOW TO ENTER

So that the registration is valid it is obligatory to fill in all of the data fields on the corresponding form and to confirm the registration. It is also obligatory to create at least one alert. 5. PRIZE

The prize in the draw is a 3D televisión.

6. COMMUNICATION OF PRIZES

On April 30th 2011 at 00:00, the promotion will close and will precede the Prize Draw of said promotion before the notary on the 9th of May 2011 in the offices of Mediterranean, in Elche Parque Industrial, Calle Severo Ochoa 44, 2nd floor.

Mediterranean will contact the winner by telephone within 72 hours of the Prize Draw. The winner has the exclusive right to enjoy the prize obtained without the possibility of applying for economic compensation in the case of renouncing the prize.



7. FISCAL

- Mediterranean applies the current fiscal legislation to the prize in this promotion.
- In the case that the winner chooses, with the agreement of Mediterranean, to give up their prize, for fiscal reasons they will continue to be considered as the beneficiary.

The prize which is the object of the draw is subject to a deposit in the account of the IRPF.
